

2021 CWA LOCAL 6222 ELECTION NOTICE and VOTING INSTRUCTIONS

Under the Supervision of the U.S. Department of Labor
Office of Labor-Management Standards (OLMS)

Enclosed is your official ballot for the election of CWA Local 6222 President, Vice President II and III, Secretary-Treasurer, and Executive Board position ASI. The term of office will be for the remainder of the unexpired term, which will end in December 2023.

1. Mark the box next to the candidate of your choice. Your vote will be **VOID** if you vote for more candidates than indicated.
2. Do not sign your name on the ballot - there must be **NO** comments or other extraneous marks written on the ballot or your ballot will be **VOIDED**.
3. Place your ballot inside the small secret ballot envelope and seal this envelope. Place the small secret ballot envelope inside the prepaid return-addressed envelope and seal this envelope.
4. To cast a valid vote, your name with mailing address label and "signature" must appear **LEGIBLY** on the lower left-hand corner of the prepaid return envelope, as this is how voter eligibility is verified.

Voter Eligibility: To be eligible to vote in the election, a member must be in good standing at the time of the tally of ballots on June 28, 2021. New members who submit a signed membership card by June 20, 2021 will be eligible to vote in the election.

IMPORTANT - Ballots must be mailed to P.O. Box 672288, Houston, TX 77267-2288 and received no later than June 28, 2021, by 10:00 a.m. in order for your ballot to count. **DO NOT bring your ballot to the Union Hall - ALL BALLOTS MUST BE MAILED.**

The ballots will be picked up from the Greens North Post Office on Monday, June 28, 2021 at 10:00 a.m., with the tally of the ballots to occur immediately following, at the CWA Local 6222 union hall, 10959 Ella Blvd, Houston, Texas 77067. Installation of officers will occur on August 5, 2021, at the regular monthly membership meeting. If necessary, a ballot tally for a run-off election will be held on Tuesday, August 3, 2021, immediately following the ballots being picked up from the post office at 10:00 a.m., at the CWA union hall. In the event of a run-off, installation of officers will occur on September 2, 2021, at the regular monthly membership meeting

Any member who does not receive a ballot in the mail or spoils their ballot should contact Election Supervisor, Alicia Harris, at (202) 906-9434 or by email to OLMS-NewOrleans@dol.gov. All ballot requests should be received by 4:00 p.m. CST on June 23, 2021. Requests received later will be honored; however, there is no guarantee that those ballots will be returned in time to be counted.

Each candidate may have observers present throughout the election process, including the tally of ballots. Candidates should submit the names of their observers in writing, by email to OLMS-NewOrleans@dol.gov, to the Election Supervisor, no less than 72 hours prior to the event that he/she will be observing. Observers will be required to present identification and sign an observer register.
